The following Notification shall be published in the Official Gazette of Government of Puducherry.

NOTIFICATION

The Lieutenant-Governor, Puducherry, is pleased to appoint Thiru N. Pakkiri, Advocate, Puducherry, as Assistant Public Prosecutor (Part Time), Puducherry, under section 25 of the Code of Criminal Procedure, 1973, on consolidated monthly remuneration of Rs.13,500/- (Rupees Thirteen thousand and five hundred only) with eight days casual leave and two days restricted holidays to conduct prosecution before the Judicial Magistrates' Court, for a period of three years, with immediate effect.

2. The terms and conditions of the above Appointee are further regulated as per the provisions mentioned in the Annexure enclosed.
3. The aforesaid appointment as Assistant Public Prosecutor shall not confer on him any right to seek regular appointment in the post of Assistant Public Prosecutor in future.
