In exercise of the powers conferred by sub-section (1) of section 32 of the Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012) read with Letter No.U-11030/7/2013-UTL, dated 4<sup>th</sup> April, 2014 of the Ministry of Home Affairs, Government of India, New Delhi, the Lieutenant-Governor, Puducherry, is pleased to appoint Thiru J. Senthil Raghavan, Advocate, Karaikal, as the Special Public Prosecutor for Karaikal District to conduct cases only under the provisions of the Protection of Children from Sexual Offences Act, 2012, for the period of three years, with immediate effect.
