In exercise of the powers conferred by sub-section (4) of section 74 of the Food Safety and Standards Act, 2006 (Central Act 34 of 2006) read with section 3(zv) of the said Act and in supersession of the Notification issued vide G.O.Ms.No.48/2015-LD, dated 12<sup>th</sup> October, 2015 of the Law Department, Government of Puducherry, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry, is pleased to appoint Thiru S.
