The following Notification shall be published in the Official Gazette of Government of Puducherry.

NOTIFICATION

In supersession of the notification issued vide G.O.Ms.No.12/2013-LD, dated 8th May, 2013 of the Law Department, Government of Puducherry, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry, is pleased to appoint Thiru. A. Senthilkumar Advocate, Karaikal, as the Additional Assistant Public Prosecutor for Karaikal Region under section 25 of the Code of Criminal Procedure, 1973 on full time basis on consolidated monthly remuneration of Rs.13,500/-(Rupees thirteen thousand and five hundred only) with eight days casual leave and two days restricted holidays to conduct cases in the Judicial Magistrates' Court at Karaikal District under the control and supervision of the Director of Prosecution, Law Department, Puducherry, for a period of three years, with immediate effect.

2. The terms and conditions of the above Appointee are further regulated as per the provisions mentioned in the Annexure enclosed.

ANNEXURE

TERMS AND CONDITIONS OF APPOINTMENT OF ADDITIONAL ASSISTANT
PUBLIC PROSECUTOR FOR KARAİKAL REGION.

1. The appointment of Thiru A. Senthilkumar , Advocate, as the Additional Assistant Public Prosecutor for Karaikal region, shall take immediate effect. But the Government are not precluded from reconsidering his appointment, if they think fit, at any time.
2. The duties of Additional Assistant Public Prosecutor is to conduct the prosecution cases before the Judicial Magistrates' Court, Karaikal.
3. He shall not appear in any Civil & Criminal Proceedings, either in original side or in appellate side against the Government and he is debarred from giving advice to private parties in any civil or criminal case in which he is likely to be called upon by the Government to tender advice.
4. He shall not undertake to defend any person or to appear against the Government in any criminal proceedings and he is not permitted to accept any engagement or fee from private parties in which he appears on behalf of the Government.
5. The Additional Assistant Public Prosecutor shall be paid travelling allowance, daily allowance as admissible to Group 'B' Gazetted Officer while travelling on official duty to outlying regions as per rules and for travel on official duty beyond a radius of 8 Kms. from Karaikal.
6. Where the Government is of the opinion that it is necessary or expedient so to do, they may, by order, for reasons to be recorded in writing relax any of the aforesaid provisions.
