In exercise of the powers conferred under sub-section (3) of Section 24 of the Code of Criminal Procedure, 1973 (Central Act No.2 of 1974), the Lieutenant-Governor, Puducherry, is pleased to appoint Thiru M.V Ramachandra Murthy, Advocate, Puducherry, as Additional Public Prosecutor to conduct cases relating to Prevention of Corruption Act, 1988, for Government of Puducherry, for a period of three years, with immediate effect.

The Lieutenant-Governor, Puducherry, is also pleased to appoint Thiru M.V Ramachandra Murthy, Advocate, Puducherry, as Special Public Prosecutor to conduct cases relating to Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989, for Government of Puducherry, for a period of three years, with immediate effect.

3. The terms and conditions of appointment of Additional Public Prosecutor and Special Public Prosecutor (POC Act, 1988 & SC/ST Act, 1989) for Government of Puducherry shall be as set out in the G.O. Ms. No.14, dated 18.02.1969 of the Home Department, Puducherry, as amended from time to time.
